5-Year Mitigation Plan Update: Public Input Needed

Brier, WA (July 7, 2009) — Mitigation is taking action to prevent or lessen the impact of an event such as flooding or earthquake. It is an important part of the emergency management cycle.

Right now, fourteen cities, towns and special purpose districts in King and Snohomish Counties are preparing their 5-year Mitigation Plan update. The participating jurisdictions are: Brier, Edmonds, Kenmore, Lake Forest Park, Lynnwood, Mill Creek, Mountlake Terrace, Mukilteo, Woodinville, Woodway, Edmonds Community College, Edmonds School District, Olympic View Water and the Port of Edmonds.
